

# SurfRay End User License Agreement (EULA)

**IMPORTANT:** PLEASE READ THE TERMS AND CONDITIONS OF THESE **LICENSE** TERMS CAREFULLY BEFORE USING THE **SOFTWARE**. SURFRAY, INC. (REFERENCED BELOW AS "SurfRay") IS WILLING TO **LICENSE** THE **SOFTWARE** TO YOU AS THE COMPANY, OR THE LEGAL ENTITY THAT WILL BE UTILIZING THE **SOFTWARE** (REFERENCED BELOW AS "YOU" OR "YOUR") ONLY ON THE CONDITION THAT YOU ACCEPT ALL OF THE TERMS OF THIS **LICENSE** AGREEMENT. THIS IS A LEGAL AND ENFORCEABLE CONTRACT BETWEEN YOU AND SURFRAY. BY INSTALLING THE LICENSE FILE, SELECTING THE "I AGREE" BUTTON OR OTHERWISE INDICATING ASSENT ELECTRONICALLY, OR LOADING THE **SOFTWARE**, YOU AGREE TO THE TERMS AND CONDITIONS OF THIS AGREEMENT. IN THE EVENT OF A CONFLICT BETWEEN THIS EULA AND THE EULA AGREED TO ELECTRONICALLY OR BY LOADING THE SOFTWARE, THIS EULA WILL PREVAIL.

IF YOU DO NOT AGREE TO THESE TERMS AND CONDITIONS, CLICK THE "I DO NOT AGREE" BUTTON OR OTHERWISE INDICATE REFUSAL, MAKE NO FURTHER USE OF THE **SOFTWARE**.

## 1. License

The software and documentation that accompanies this license (collectively the "Software") is the property of SurfRay, or its licensors, and is protected by copyright law. While SurfRay continues to own the Software, You will have certain rights to use the Software after Your acceptance of this license. This license governs any releases, revisions, or enhancements to the Software that SurfRay may furnish to you.

Server software provides services or functionality on a server (Computers able to run the server software are servers)

Devices allow users to access or use the Server software. A device can be a personal computer, a workstation, a telephone, a Personal Digital Assistant, or other electronic devices.

The license given to you is divided into a number of server licenses and a number of user licenses.

Your rights and obligations with respect to the use of this Software are as follows.

You may:

- a) Install and use as many copies of the server software as stated in the License Agreement and the adjoining License File; and as many copies of the documentation as may be reasonably required. Your License File shall constitute proof of your right to make such copies. SurfRay keeps track of all license files issued.
- b) Access the functionality and services using one or more devices allowing a number of unique users limited by the numbers of user licenses issued in this Agreement and the adjoining license file.
- c) Make reasonable number of copies, either by electronic media or onto the hard disk of your computer for archival and/or disaster recovery purposes.
- d) After written notice to SurfRay, transfer the Software on a permanent basis to another person or entity, provided that You retain no copies of the Software and the transferee agrees to the terms of this license; and
- e) Use of the Software for all purposes for which the Software was designed.

You may not:

- a) sublicense, rent, or lease any portion of the Software; reverse engineer, decompile, disassemble, modify, translate, make any attempt to discover the source code of the Software, or create derivative works from the Software;
- b) use the Software as part of a facility management, timesharing, service provider, or service bureau arrangement;

- c) use a previous version or copy of the Software for more than a reasonable amount of time after you have received a disk replacement set or an upgraded version. Upon upgrading the Software, all copies of the prior version must be destroyed;
- d) use a later version of the Software than is provided herewith unless You have purchased software assurance or have otherwise separately acquired the right to use such later version;
- e) use, if you received the software distributed on media containing multiple SurfRay products, any SurfRay software on the media for which you have not procured.
- f) use the Software in any manner not authorized by this license; nor
- g) use the Software in any manner that contradicts any additional restrictions set forth, below.

## **2. Product Installation and Required Activation:**

There are technological measures in this Software that are designed to prevent unlicensed or illegal use of the Software. You agree that SurfRay may use these measures to protect SurfRay against software piracy. This Software may contain enforcement technology that limits the ability to install and uninstall the Software to specific servers. This License and the Software containing enforcement technology require activation as further set forth in the documentation. The Software will only operate for a finite period of time prior to Software activation by you. If you do not complete the activation within the finite period of time set forth in the documentation, or as prompted by the Software, the Software will cease to function until activation is complete, which will restore Software functionality. In the event You are not able to activate the Software, You may contact SurfRay Customer Support at the URL and telephone number provided by SurfRay during activation for prompt resolution, or as may be set forth in the documentation.

In the event that You require replacement keys for products procured, they will be provided to you at no additional costs for the duration of the support agreement.

## **3. Intellectual Property**

All intellectual property in the Software and any documentation relating thereto and the ownership of any idea, method, invention, discovery, design or other work, including computer programs or parts thereof conceived or made by SurfRay in the course of providing the Software belong to SurfRay.

All notes, memoranda, correspondence, documents and other tangible items made or delivered by SurfRay are also included in the intellectual property rights of SurfRay.

You shall acknowledge that SurfRay may grant other parties rights to use the Software partly or wholly and SurfRay will retain all right, title and interest in and to all software development, tools, know-how, methodologies, processes, technologies or algorithms used in providing the Software which are based on trade secrets or proprietary information of SurfRay or are otherwise owned or licensed by SurfRay and that SurfRay will be free to use the ideas, concepts and know-how which are developed in relation to the Software.

You shall have no right to use for any purpose any trade mark or service mark belonging to SurfRay without SurfRays prior written consent.

Licensee shall retain all rights in and to License provided materials and content.

For Intellectual Property Indemnity

SurfRay will defend, indemnify and hold The End User, its Affiliates, and their respective officers, directors, employees and agents harmless from and against any and all damages, demands, claims, losses, actions, liabilities, lawsuits, judgments and expenses (including without limitation, reasonable attorney's fees and expenses) arising out of, relating to, or in connection with (a) claims against The End User that any Services performed by Provider or any Deliverables and/or Work Product conceived, created, performed or produced by Provider or their use by The End User infringes, violates or misappropriates any intellectual property rights of a third-Party.

## **4. Limited Warranty:**

SurfRay warrants that the media on which the Software is distributed will be free from defects for a period of sixty (60) days from the date of delivery of the Software to You. Your sole remedy in the event of a breach of this warranty will be that SurfRay will, at its option, replace any defective media returned to SurfRay within the warranty period or refund the money You paid for the Software. SurfRay warrants that the software will perform in substantial conformance with its Published Specifications, a copy of which has been delivered to Licensee. SurfRay does not warrant that the Software will meet your requirements or that operation of the Software will be uninterrupted or that the Software will be error-free. Further, SurfRay does not make any warranties with respect to third party software unless same is integrated with the Software and except as provided in the Published Specifications Software's interoperability with Your hardware.

TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, THE ABOVE WARRANTY IS EXCLUSIVE AND IN LIEU OF ALL OTHER WARRANTIES, WHETHER EXPRESS OR IMPLIED, INCLUDING THE IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, AND NONINFRINGEMENT OF INTELLECTUAL PROPERTY RIGHTS

This Agreement will be governed by the laws of California. These terms and all License Files jointly form the entire Agreement between You and SurfRay relating to the Software and: (i) supersedes all prior or contemporaneous oral or written communications, proposals, and representations with respect to its subject matter; and (ii) prevails over any conflicting or additional terms of any quote, order, acknowledgment, or similar communications between the parties. This Agreement shall terminate upon your breach of any term contained herein and You shall cease use of and destroy all copies of the Software. The disclaimers of warranties and damages and limitations on liability shall survive termination. This Agreement may only be modified by a written document that has been signed by both You and SurfRay.
